Curriculum Giveaway Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility

The Lillio Learning powered by FunShine Express Curriculum Giveaway (the “Giveaway”) is open only to legal residents of the fifty (50) United States (and the District of Columbia), who are at least eighteen (18) years old at the time of entry. Void where prohibited. Proof of residency and age may be required. Employees and directors of Lillio Learning and their subsidiaries, divisions, affiliates, and advertising or promotional agencies, or individuals involved with the design, production, execution or distribution of the Giveaway and the immediate family and household members of such individuals, are not eligible to enter to win. “Immediate family members” shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses, regardless of where they live. “Household members” shall mean people who share the same residence at least three months a year, whether related or not. In order to enter the Giveaway or receive a prize, you must fully comply with the Official Rules and, by entering, you represent and warrant that you agree to be bound by these Official Rules and the decisions of the Sponsor, whose decisions shall be binding and final in all respects relating to this Giveaway. The Giveaway is governed by these Official Rules and is subject to all applicable federal, state, and local laws.

2. Sponsor

Lillio Learning powered by FunShine Express, 926E East Industrial Drive, Dickinson, ND 58601 (“Sponsor”)

3. Timing

The Curriculum Giveaway begins January 13th, 2026 at 12:01 a.m. Central Standard Time and ends February 13th, 2026 at 11:59 p.m. Central Standard Time (“Giveaway Entry Period”). Sponsor is the official time keeper for this Giveaway.

4. How to Enter

- A. Order Lillio Learning for Infant & Toddler Classrooms, Lillio Learning for Preschool Classrooms, or FunShine Digital curriculum (“Curriculum”) for February and/or March. Any customers who have already ordered Curriculum before the entry period began were automatically entered into the drawing. Each monthly Curriculum (Infant & Toddler order, Preschool order, and FunShine Digital account) counts towards one (1) entry. Eligible orders include Teacher Packs, Full Kits, and FunShine Digital paid accounts. January/February Infant & Toddler Curriculum counts as one (1) entry and March/April Infant & Toddler Curriculum will count as one (1) entry. February Preschool and March Preschool each count as one (1) entry. Paid FunShine Digital accounts for one (1) or more subscriptions equals one (1) entry. Supply only orders are not eligible. “Supply only” shall mean Starter Packs, Sample Kits*, Parent Note Pads, Child Progress Reports, Discovery Journals, Children’s Book Bundles, Toy Bundles, or any other item purchased separately from Curriculum. *Note: Sample kit orders are eligible for one entry for new Lillio Learning customers only. Does not apply to any customers who previously ordered Curriculum.
- B. Refer a friend. When referring a friend to order Curriculum, the referral will receive one (1) entry into the Giveaway when they meet the conditions of entry method A, and the referrer will also receive one (1) entry. The referred person must mention the name of the referrer in order for the referrer to earn an entry into the Giveaway. Referrals are also subject to the Customer

Referral Program, where the referral can receive a \$50 discount on their Curriculum for mentioning the referrer's name at the time of the order, only if they are a new customer. If a referral is not a new customer, no discount will be given, and the referral and referrer will each still earn one (1) entry into the Giveaway. A "new customer" is defined as a person who has not ordered any Curriculum from the Sponsor within the last 3 years.

- C. Free Entry by Mail: During the Giveaway Entry Period, print your first name, last name, email address, and zip code on a 3"x5" card and mail it to: Curriculum Giveaway, 926E East Industrial Drive, Dickinson, ND 58601. Mail in entries must be postmarked within the Giveaway Entry Period and received by February 13th, 2026. Limit of one (1) mail-in entry during the Giveaway Entry Period.

Limit of ten (10) entries per person during the Curriculum Giveaway Entry Period regardless of method of entry.

Use of any automated system to enter is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected entries all of which will be ineligible to win a prize. All entries become the sole and exclusive property of Sponsor and will not be returned or cancelled.

5. Winner Determination

On or about February 28th, 2026, Sponsor will select one (1) entry for each prize described below in a random drawing of all valid entries received. The Potential Curriculum Giveaway Winners ("Winner(s)") will be contacted using the email address provided with the entry and may be awarded the prize subject to verification of eligibility and compliance with the terms of these Official Rules. The Winners will be notified by email on or about March 2nd, 2026. Failure by Winners to respond to the initial verification within two (2) weeks after three (3) attempts will result in disqualification and Sponsor will select an alternate Winner in the same manner. Odds of winning a prize depend on the number of eligible entries received during the Giveaway Entry Period. Limit of one (1) prize per person for the Giveaway.

WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR. SPONSORS DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE ADMINISTRATION, OPERATION, SELECTION OF THE WINNER, AND OTHER MATTERS RELATED TO THE GIVEAWAY.

6. Verification of Winners

Winners may be required to complete and return an Affidavit of Eligibility, Release of Liability, and Publicity Release (where permitted by law) (collectively, the "Affidavit") by the date specified by the Sponsor, or an alternate Winner may be selected. In the event: (a) Winner cannot be reached for whatever reason after a reasonable effort has been exerted or the Winner notification or Affidavit is returned as undeliverable; (b) Winner declines or cannot accept, receive or use the prize for any reason; (c) of noncompliance with the above or within any of the aforesaid time periods, (d) Winner is found to be ineligible to enter the Giveaway or receive the prize, (e) Winner cannot or does not comply with the Official Rules, or (f) Winner fails to fulfill the Affidavit-related obligations, the Winner shall be disqualified from the Giveaway and an alternate Winner may be selected, at Sponsor's sole discretion, from among the other eligible entries received. Sponsor reserves the right to modify the notification and Affidavit procedures in connection with the selection of alternate Winner, if any.

7. Prizes

- A. Grand Prize: One (1) Grand Prize will be awarded. Grand Prize Winner will receive one (1) year (up to twelve (12) months) of Curriculum with a value up to \$2,000.

- B. Second Prize: Two (2) prizes will be awarded. Second Prize Winners will receive one (1) month of Curriculum with a value up to \$200.

Value of Curriculum must be equal to or less than the number of children, Teacher Packs, or FunShine Digital subscriptions that were ordered for February or March 2026. For example, if the order was for a Preschool Kit for 6 children for February, the prize will be for 6 children. The Winner is responsible for the cost of any additional materials should the winner want supplies for additional children, Teacher Packs, or FunShine Digital subscriptions. If more than one curriculum is ordered, such as both Infant & Toddler and Preschool, prize will only include one (1) Curriculum of Winner's choice. Redeemable prize may be less than the Grand Prize of \$2,000 or Additional Prize of \$200, if February or March order does not exceed the value of the prize. If the value of Curriculum ordered is greater than the value of either prize, Winner is responsible for any additional costs. Prizes must be redeemed by September 1st, 2026 at 11:59 p.m. Central Standard Time. Grand Prize can only be redeemed in consecutive months, or the Winner will give up any further redemption of Curriculum. Winner acknowledges that all prizes are awarded as-is without warranty of any kind.

10. General Conditions

Sponsor and its subsidiaries, affiliates, divisions, partners, representatives, agents, successors, assigns, employees, officers, and directors shall not have any obligation or responsibility, including any responsibility to award any prize to entrants, with regard to: (a) entries that contain inaccurate

information or do not comply with or violate the Official Rules; (b) entries, prize claims or notifications that are lost, late, incomplete, illegible, unintelligible, damaged, or otherwise not received by the intended recipient, in whole or in part, due to computer, human, or technical error of any kind; (c) entrants who have committed fraud or deception in entering or participating in the Giveaway or claiming the prize; (d) telephone, electronic, hardware, software, network, Internet, or computer malfunctions, failures or difficulties; (e) any inability of the Winner to accept the prize for any reason; (f) if a prize cannot be awarded due to delays or interruptions due to Acts of God, natural disasters, terrorism, weather or any other similar event beyond Sponsor's reasonable control; or (g) any damages, injuries or losses of any kind caused by any prize or resulting from awarding, acceptance, possession, use, misuse, loss, or misdirection of any prize or resulting from participating in this Giveaway or any promotion or prize related activities.
